# COUNTY ADMINISTRATOR'S REPORT OF COUNCIL ACTIONS REGULAR SESSION COUNCIL MEETING May 15, 2007 6:00 PM

**Public Works Week, May 19 – 26, 2007:** Hutchinson and Scott presented Public Works Director Teresa Smith with a resolution honoring Public Works Week. Public Works employees in the audience were also recognized for their service to the County.

**Transportation Study Commission:** Bill Leidinger, Chair of Mass Transit Subcommittee, and Ernest Baughman, Parsons Brinckerhoff, gave an update on the Transportation Study Commission. Council requested that this presentation be given to City Council. **ACTION: ADMINISTRATION** 

Citizens' Input: No one spoke.

Legal Review of Sanitary Sewer Extension Agreements for 1) Rothstein Tract; 2) Eagle's Rest Subdivision; and 3) River Shoals Subdivision: Mr. Smith stated that legal staff reviewed the sanitary sewer extension agreements and have amended the agreements consistent with the motion that was made at the previous meeting and he believed they are consistent with the 1995 Court Order.

Council approved the three agreements with the following change to the Rothstein Agreement: the words "are entered into as a result of a court order" were stricken so that the agreement solely deals with the prior agreement(s) or written one(s) between the parties. All of the agreements are to have a life span of ten years versus five years on all tap certificates. ACTION: ADMINISTRATION, LEGAL, PUBLIC WORKS, UTILITIES

The second part of the Administrator's recommendation regarding capital grants was referred to back to the D&S committee for the purpose of addressing an amendment to the County's Animal Registration Ordinance to create a structure which will have separate licensing fees for unspayed and unneutered and spayed, neutered and micro-chipped animals and then would work with Lexington County and Project Pet to develop a bond ordinance to use those fees to retire the bond debt. The Chairman is also to appoint a special committee to work with Lexington County Council to move this matter along. ACTION: ADMINISTRATION, ANIMAL CARE, LEGAL, PROCUREMENT
