- a. Gateway Detention Pond/Quitclaim Council gave third reading approval to a quitclaim deed by which Richland County's interest in a drainage easement in the Gateway Development is conveyed to the current property owners. ACTION: LEGAL/PUBLIC WORKS
- **b.** Gateway Drainage Easement Council gave third reading approval to quit claim deeds by which the County's interest in a drainage easement in the Gateway Development is conveyed to the current property owners.
 ACTION: LEGAL/PUBLIC WORKS
- c. Ordinance Amendment: Quit Claim Deeds in the Olympia Community – Council deferred the item.

2. SECOND READING ITEMS

a. 03-01MA, Greg Douglas, from D-1 to RS-3, single family detached S/D, TMS 19803-03-07, Windsor Lake Blvd – Council deferred the item until a correction to the ordinance is made.

b. 03-36MA, Greg Lehman, from RU to PUD-1R, single family detached sbdv., TMS 10506-02-01/02 & 01509-01-01, Three Dog Road near Lake Murray Elementary – Council gave second reading approval to an amendment that would change the zoning from RU to PUD-1R. ACTION: LEGAL/PLANNING

3. REPORT OF DEVELOPMENT AND SERVICES COMMITTEE

- a. Ordinance to Authorize easement to SCE&G at the County Administration Building – Council approved the ordinance authorizing the granting of a utility easement to SCE&G at the County Administration Building for the removal, replacement, and setting of utility poles. ACTION: LEGAL
- b. Broad River Heights Sanitary Sewer project condemnation Council approved the condemnation of an easement located at 3808 Brewer Street, which is required for the construction of the Broad River Heights Sewer Project. ACTION: LEGAL
- c. Award of contract for HVAC renovation/replacement at the Judicial Center, Administration Building and Health Department -- Council approved the award of contract for the design and evaluation of the Judicial Center's HVAC system. ACTION: ADMININISTRATION, LEGAL, PROCUREMENT, PUBLIC WORKS

4. **REPORT OF ADMINISTRATION AND FINANCE COMMITTEE**

- **Airport Terminals & Hangars** Council gave first reading approval to an ordinance authorizing the County to issue bonds in the amount of \$2,837,871 for the construction of a new Terminal Building, 18 T-hangars, and six corporate box hangars at the Columbia Owens Downtown Airport, all of which is contingent upon realization of the projected revenue including the awarding of grant amounts included in the projections.
 ACTION: ADMINISTRATION, LEGAL, PROCUREMENT, PUBLIC WORKS, AIRPORT COMMISSION
- b. CASA Request for full-time employee Council approved the request with consideration of revenue raised by the CASA Board. ACTION: CASA, HUMAN RESOURCES, BUDGET, FINANCE

- c. Sheriff's Department: Storage Building Council authorized the Administrator to use \$158,000 of Construction Bond proceeds and \$42,000 from the 2002 Detention Center Bond to fund the Storage Shed project and authorized rebidding the project. Council also included a 15% contingency fee. ACTION: ADMINISTRATION, PROCUREMENT, SHERIFF, PUBLIC WORKS
- **d.** East Richland County Public Service District: Bond Issuance Council received this item as information. No action was necessary.
