### Welcome and Call to Order

**Chairman Purcell** called the meeting to order and announced a quorum in attendance. He welcomed everyone and called for the invocation. The invocation was delivered by **Commissioner Christopher.** He also welcomed **Commissioner McCreary** as the newest member of the Airport Commission.

### **Election of Officers**

**Commissioner Dean** reported on the activities of the Nominating Committee for 2015 which recommended the following slate:

There were no other nominations from the floor and the slate was approved unanimously. **Vice Chairman Dean** offered a statement of appreciation on behalf of the entire Commission for the outstanding leadership of **Commissioner Purcell** during his tenure as Chairman.

### **Approval of Minutes**

**Chairman Christopher** presented the minutes of the November 17, 2014 Airport Commission meeting for approval. **Commissioner Dean** made a motion to approve the minutes as presented, **Commissioner Goudelock** seconded, and all approved.

### Approval of Agenda

**Chairman Christopher** presented the agenda as circulated. **Commissioner Dean** made a motion to approve the agenda as presented, **Commissioner Goudelock** seconded, and all approved.

### **Report of Items for Executive Session**

**Mr Eversmann** reported that there was an item of a contractual nature to be discussed in Executive Session.

### **Presentation**

**Mr Richard Leaphart** with SCANA provided a presentation regarding a request of a 15 foot utility easement to be granted. The goal of the project, for which this easement is being requested, is to tie two existing circuits together and convert the older circuit from 8 KVA to 23 KVA. **Commissioner Mayers** asked about placement of lines underground and he noted that the preference of the neighborhood would be a underground conversion. **Commissioner Mayers** requested that the President of SCANA speak to the issue based on previous discussion in years prior. **Commissioner Dean** expressed concern of the placement of two poles near the Curtiss-

Wright Hangar. **Commissioner Hope** spoke to the visual effect of the utility poles which are currently in place along Jim Hamilton Boulevard.

**Mr Leaphart** stated the poles would be standard wood material, but was unsure if any transformers would be affixed to them. **Commissioner Dean** asked about the project schedule and if there was time to look at other alternatives and gather more information. It was noted that this request for the granting of an easement will go directly to County Council from the Airport Commission.

**Commissioner Dean** suggested that a rendering be prepared and submitted to the Commission prior to making a decision. **Commissioner Goudelock** stated he believed the project would be beneficial to both the Airport and the community. **Commissioner McCreary** asked for more information and **Commissioner Cole** wanted to know if cost for underground conversion is feasible, or not? **Mr Leaphart** stated that the underground conversion is costly and most efficient in new neighborhood developments.

**Commissioner Dean** noted his concerns for the aesthetics of the project. **Commissioner Goudelock** stated that the underground conversion is really too large to tackle at the present time and asked that the Commission focus on addressing the immediate needs and the request before them. **Chairman Christopher** acknowledged that the issue of underground conversion was larger than the Commission was prepared to address. **Commissioner Goudelock** made a motion to defer this issue, and requested a rendering of the project. **Commissioner Dean** seconded the motion and all were in favor.

<u>Chairman's Report</u> – Commissioner Purcell (*immediate past Chairman*) discussed the upcoming SC Aviation Association Annual Conference (February  $11^{th} - 13^{th}$  at the Wild Dunes Resort). 

#### Phase I – Initial Clearing & Stub Taxiway 'D'

(Clearing ~ 15 acres, Stub Taxiway 'D' Construction, Marking & Lighting)

- Open Bid Early April 2015
- → Construction Start Early May 2015

#### Phase II – Stormwater Pipe & Taxiway Extension

(Erosion Control, 21 ft. Stormwater Pipe, Taxiway Extension Construction/Old Taxiway Demolition)

- → Advertise Bid Mid May 2015
- ➔ Open Bid Mid June 2015
- Construction Start Mid August 2015 (Dependent on FAA Funding Schedule)
