Welcome and Call to Order

Chairman Purcell called the meeting to order and announced a quorum in attendance. He welcomed everyone and called for the invocation. The invocation was delivered by **Commissioner Cole**

Approval of Minutes

Chairman Purcell presented the minutes of the September 9, 2013 Airport Commission meeting for approval. **Commissioner Goudelock** made a motion to approve the minutes as presented, **Commissioner Christopher** seconded and all approved.

Chairman Purcell presented the agenda as circulated. **Commissioner Goudelock** made a motion to approve the agenda as presented, **Commissioner Christopher** seconded and all approved.

Report of Items for Executive Session

Mr Chris Eversmann reported that a contractual matter update is needed to be discussed during the executive session scheduled at the end of the meeting.

Presentation

Before the scheduled presentation, **Mr Eversmann** took the opportunity to recognize and acknowledge the exemplary job performance of **Mr Cliff Snelgrove** of the airport staff. Mr Snelgrove is a maintenance worker assigned to the airport from the Facilities & Grounds Division. Mr Eversmann informed the Commissioners that Cliff was one of the best, if not the best, maintenance employee he has ever had the honor to work with. Commissioner Mayer conveyed his appreciation to Cliff as well.

Mr Martin Keany, Executive Director, McNAIR Center for Aerospace Innovation & Research, had a successful career as a Naval Aviator to include multiple command assignments. Following retirement from the Navy, he found his way back to Columbia and has been aboard as the first Executive Director of the McNAIR Center for several months. The ultimate goal for the McNAIR Center is to become self-sustaining (via private funding). To date, the Center has received benefactor contributions in excess of \$11 million. The mission and functions include collaborative education, economic development, materials and composites, system engineering and design, testing and NDE certifications, lifecycle monitoring and automated manufacturing. Additionally, there are aspirations for Supply Chain Management, Power Control and Energy, System Design and Cyber Security. The McNAIR Center staff is also working to create a business incubator atmosphere. A unique capability of The McNAIR Center is Fiber Placement machines: USC is the only college campus with that capability.

Following **Mr Keany's** presentation, a neighborhood complaint regarding the recent separate visits by two vintage aircraft (B-17F and Ford Tri-Motor) during the month of October was discussed. **Mr Eversmann** stated that because of our FAA Grant Assurances, we cannot refuse visits by any aircraft for reasons other than facility constraints. Additionally, he said that inquiry of the National Transportation Safety Board (NTSB) and the Commemorative Air Force (CAF) indicated no research regarding the accident rate and relative safety of vintage aircraft as

compared to all aircraft. However, it was opined by these safety and vintage aircraft experts that since these aircraft are typically so rigorously maintained, that they may in fact be safer than the fleet as a whole. Both pilot crews were briefed on noise abatement procedures, but neighborhood overflights (presumable at the proper altitude) did occur nonetheless. Also, interest in both visits, which were publicized in advance, was extremely high and, therefore, there was an extremely high rate of activity. Finally, the close proximity of these visits was pure coincidence; we will likely not see any other such visits for many months or even years. This was the only complaint received. The person who made the complaint was present and appreciated the discussion and consideration.
