# Welcome, Call to Order, and Invocation

**Chairman Purcell** called the meeting to order and announced a quorum in attendance. He welcomed everyone and called for the invocation. The invocation was delivered by **Commissioner Goudelock.** 

#### **Approval of Minutes**

**Chairman Purcell** presented the minutes of the March 11, 2013 Airport Commission meeting for approval. **Chairman Purcell** made a motion to approve the minutes as presented, **Commissioner Goudelock** seconded, and all approved.

### Approval of Agenda

**Chairman Purcell** presented the agenda as circulated. **Chairman Purcell** made a motion to approve the minutes as presented, **Commissioner Hope** seconded, and all approved.

**Presentation** – **Chris Eversmann** introduced **Major Walter Hummel** who is with the McEntire Joint National Guard Base. He is a 1995 graduate of the University of South Carolina. He was previously assigned to Myrtle Beach Air Force Base and has 13 years as an enlisted Air Traffic Controller. **Major Hummel** gave a PowerPoint Presentation which included images of the base and runway. The various based aircraft include 26 – F-16s' and over 50 helicopters. Roughly 2,000 people are working on base during a typical Reserve Drill Weekend. There are 300 full time personnel within the Air Force organization and approximately 250 in the Army organization. The 169th Fighting Wing is the largest Air Force unit while the Army organization is made up of ten smaller units on the base. He briefed air traffic control radar systems and the "suppression of enemy air defense" (SEAD) mission as well. There are 88 Air National Guard Wings and ten Air Traffic Control Squadrons in the entire Nation. McEntire has the ability to deploy an entire aviation package for a 120 day period. Participation by most personnel in unit deployments is voluntary.
