Welcome, Call to Order, and Invocation

Chairman Purcell called the meeting to order and announced a quorum in attendance. He welcomed everyone and called for the invocation. The invocation was delivered by **Vice Chairman Christopher.**

Councilman Dean reported that all currently serving officers were willing and eligible to continue serving. A call for nominations from the floor was made, but none were received. The proposed slate of existing officers was approved by acclamation of the Commission. These officers, however, will not be eligible to serve in the same positions next year.

Approval of Minutes

Report of Items for Executive Session

Mr Eversmann reported that a contractual matter update is needed to be discussed during the executive session scheduled at the end of the meeting.

Presentation

Mr Delphin Gantt, Jr, Chairman, South Carolina Aeronautics Commission, provided a presentation on the status of the South Carolina Aeronautics Commission (SCAC). The SCAC was re-established in 2004 under the State Department of Commerce. In 2009, the Commission was administratively placed under The State Budget and Control Board organization. The Commissioners serve a four-year term, overseeing the safety of South Carolina's Public Use Airports. The organization consists of two departments: Airport Development, and Flight Operations. The Airport Development Department is responsible for:

- → Financial and technical assistance to Public Use Airports within the State;
- → Airport Capital Improvement Plans (ACIP);
- → Engineering Design review and Construction Inspection services;
- → Airport maintenance assistance services; and
- → Airport activity and safety.

Flight Operations is responsible for transportation for the Governor, Constitutional Officers, State Agencies, State Educational Institutions, and Economic Development prospects. All fly on a "First come / First fly" basis and it is operated as a business enterprise. Also, they have logged over 91,700 air miles with no accidents.

The Commission's primary challenge is adequate funding. Since moving to the Budget and Control Board, funding has been reduced by about 70% from previously established levels. Though they are lacking appropriate funds to manage statewide aviation mandates, they are a small agency doing "a lot with a little." Their key partners include: the FAA, the Columbia FSDO, the Atlanta ADO, the SCAA and the SC Aviation Safety Council.
