Welcome, Call to Order, and Invocation

Report of Items for Executive Session

Presentation

Ms Peggy Roberson provided a brief on the upcoming, third-annual Hamilton-Owens Palmetto Cup / Earl Yerrick Memorial Aircraft Static Display on April 12th. The proceeds from this event will again be given to the benefit the American Cancer Society. There will be a variety of interesting aircraft on display to the public as well as many participating in the Aerial Scavenger Hunt.
