Airport Director's Report

Mr Eversmann welcomed employees from Aircraft Maintenance Service (AMS), the newest business tenants at the airport. **Mr Frank Schumpert**, President of AMS, acknowledged his pleasure to be here and noted the great support provided to the airport by Richland County. One of AMS' employees, **Mr Joshua Snipes**, provided a brief on the upcoming, mandatory requirement for Automatic Dependent Surveillance – Broadcast (ADS-B) upfit compliance for all aircraft by January 1, 2020. This is part of the NextGen initiative to modernize management of our airspace. A basic ADS-B compliance upfit installation cost is roughly \$5,000 per aircraft.

Airport News

On July 22, 2014 a based aircraft (N5341S) on approach to Runway 13 clipped the power lines at the intersection of Commerce Drive and Express Drive. There were no fatalities or injuries and
