



Fuel Farm Repairs

- Repair perimeter fence
- Saw cut / demolish concrete pad
- Excavate area surrounding manhole and vent tube
- Replace vent tubes and covers on both tanks

 Confined space entry / tank inspection
- Repair minor cracks in manhole riser (Jet A)
 Replace manhole riser (AvGas)
- Replace sump pumps / fix float Clean tank interior
- Replace conduit and cable
- Backfill / compact
- Form / pour replacement concrete pad \$48,000

- Insurance claim pending
 Future project to harden perimeter



Lift Station Failure

- → Discovered on September 28th
- → Failure of primary and secondary pumps
- → Failed lift station never overflowed despite heavy inflow
- → Initial response by contractor (PASCON)
- → Multiple daily pump out required (\$3,000 / day)
- → Response taken over by RC Utilities on September 30th
- > Took over daily pump outs of lift station
- + Removed failed pumps
- → Purchased, adapted, and installed a temporary replacement pump (\$2,000)
- → Mobilized a pump vendor for rebuild / replacement
- → Back up and running by noon on October 1st
- → Purchasing two, new replacement pumps and rebuilding one of the failed pump (special operating stock) (\$15,210)

Runway Excursion



- → Occurred on Tuesday, October 5th.
- → Based aircraft.
- > No injuries, explosion, or facility damage.
- → No Runway closure required.
- → Disabled aircraft retrieved early the following morning.

Glider Crash

- → Occurred at 1130 on Thursday, October 21st.
- → Based aircraft.
- → First Responders on site within four minutes.
- → Pilot injured and medevac'd.
- → Runway 13-31 temporarily closed.
- > Initial investigation response provided by the FAA.
- → Aircraft moved once cleared by FAA staff. Area FOD Cleanup proceeded and Runway reopened by 1430.
