The meeting was called to order at approximately 4:49 p.m.

APPROVAL OF MINUTES

The minutes were approved as submitted

ADOPTION OF AGENDA

Item number 13 was moved under Item 6 and became Item 6b. The agenda was adopted with that change.

INTERVIEWS

Accommodations Tax Committee-3 (needed are 1 person from the Hospitality Industry, 1 person from the Lodging Industry, and 1 person from the cultural industry)

No applications were received. The committee recommended this item be re-advertised.

Building Codes Board of Appeals-3 (needed, 1 engineer, 1 person from the gas industry, and 1 person from the building industry) Applications were received from the following: Jesse S. Burke, Engineer; Michael T. Lowman, Building*; Greg Mackie, Gas* - After interviewing the applicants the Committee recommended reappointing Mr. Lowman and Mr. Mackie, and the appointment of Mr. Burke.

<u>Community Relations Council-1; No applications have been received</u> –the Committee recommended this position be re-advertised.

Planning Commission-1; an application was received for the following: William H. Theus –the Committee interviewed Mr. Theus and discussed possibly going to the roundtable to provide criteria to the Rules Committee so they will know what the Planning Commission is looking for in an applicant. The Committee then recommended Mr. Theus for appointment.

ITEMS FOR ACTION

Agendas-FOIA Compliance – the Committee received this as information.

Appearance Commission: [MALINOWSKI]

- a. Determine what constitutes a quorum for the Appearance Commission and have the Ordinance reflect that.
- b. Require all Council members appoint a representative to the Appearance Commission by the July 31, 2012 Council meeting.

The Committee accepted the language provided by the Legal Department with the amendment that the Commission needs to have eleven members, and at least one of the members be a professional.

<u>I move Council consider allowing Master Gardeners to fulfill the roles of</u> <u>Landscaper and Horticulturalist on the Appearance Commission, in the event that</u> <u>no licensed Landscaper or Horticulturalist can be recruited for the Commission. I</u> <u>also encourage all Council members to appoint their candidates to this commission,</u> <u>and request staff to inform Council of vacancies [HUTCHINSON]</u> –the Committee decided to get with Ms. Hutchinson to see if the action taken on the item above would suffice.

Add to Section 4.1 of Council Rules: "No standing committees of Council shall be scheduled at the same time." [LIVINGSTON] – the Committee accepted the language on page 40, and recommended forwarding this item to Council with a recommendation for approval.

That all items currently listed at the end of the A&F and D&S Committee agendas as "Items Pending Analysis" be cleared up within 90 days. There is no reason some action should not be taken, even if it means to table it for now [MALINOWSKI] – the Committee accepted the language with the change to 100 days. The Committee recommended this item be forwarded to Council with a recommendation for approval.

<u>Midlands Workforce Development Board-1</u> <u>One applicant was nominated, Annie Caggiano, Richland County Economic</u> <u>Development; she will be replacing Nelson Lindsay, Richland County Economic</u>

Development Director – the Committee accepted the nomination of Ms. Caggiano to the Board, and forwarded this item with a recommendation to approve.

<u>Reviewing Committee Qualifications</u> – the Committee recommends the following departments for consideration by the Internal Audit Committee: Finance, Procurement, Timekeeping, Roads and Drainage. The Committee asked to have the audit process begin.

DISCUSSION

Due to recent issues with the Chair making announcements and having meetings on behalf of Richland County and County Council without Council's approval, I move that we have a workshop on the rules of the Chair. The dos and don'ts of the Chair. This will help with the problem and the chaos we are having on County Council [JACKSON] –the Committee asked staff to have dates for a workshop prior to a council meeting, and have the chair to commit to a date.


