Case # 14-27 MA, Daryl Barnes, RS-LD to NC (.57 acres), TMS # 21710-01-01, 5430 Lower Richland Boulevard: Council unanimously deferred the second public hearing and any action on this rezoning request to the December Zoning Public Hearing. ACTION: PLANNING

Case # 14-29 MA, Thomas Crowther, RU to GC (15.43 acres), TMS # 20200-03-45, Clemson Road: The public hearing was opened. The applicant and ten (10) others, including several representatives for the applicant, spoke in favor of the rezoning. Seven (7) people spoke against the rezoning. The public hearing was closed. Council denied the rezoning request in a vote of 9-1. ACTION: PLANNING

Case # 14-32 MA, M. Everett Smith, RS-MD to OI (.54 acres), TMS # TMS#07307-05-12 (p), 1224 Broad River Road.: The public hearing was opened. Four (4) people spoke against the rezoning. The public hearing was closed. Council unanimously denied the rezoning request. ACTION: PLANNING

Case # 14-33 MA, DR Horton-Crown, LLC, RU to RS-LD (48.89 acres), TMS # 04300-01-07, Old Tamah Road.: The public hearing was opened. The applicant and one (1) other person spoke in favor of the rezoning. Nine (9) people spoke against the rezoning. The public hearing was closed. Council unanimously denied the rezoning request. ACTION: PLANNING

Case # 14-34 MA, Michael Smith, RU to MH (26.86 acres), TMS # 33300-03-34 & 41, Old Leesburg Road: The public hearing was opened, but no one spoke. The public hearing was closed. Council unanimously denied the rezoning request. ACTION: PLANNING

Case # 14-35 MA, Mark Jeffers, RS-MD to NC (1.04 acres), TMS # 22905-01-79, North Springs Road: Council unanimously deferred the public hearing and any action on this rezoning request to the January Zoning Public Hearing. ACTION: PLANNING

Text Amendments:

An Ordinance Amending the Richland County Code of Ordinances, Chapter 26, Land Development; Article II, Rules of Construction; Definitions; and Article V, Zoning Districts and District Standards; Section 26-141, Table of Permitted Uses, Permitted Uses With Special Requirements, And Special Exceptions; Subsection (F), Table Of Permitted Uses, Permitted Uses with Special Requirements, and Special Exceptions; so as to Permit Non-Hazardous Sludge in the HI (Heavy Industrial District) with Special Requirements.
