Mr. Pearce expressed concern about applying for federal funds for the dams when there are a series of referendums lined up. Additionally, Lake Elizabeth is not addressed at all and there is a major highway running over it.

Mr. Bronson stated the funds being applied for are to armor or strengthen dams and not to repair dams.

Mr. Pearce stated there is currently not a dam at Cary Lake; therefore, how can it be fortified?

Staff responded that once the Cary Lake Dam has been repaired by the HOA the dam will be armored to make it more resilient.

The committee voted unanimously to move forward as outlined above.

Mr. Huguley moved, seconded by Mr. Miarka, to direct staff, after reviewing the Federal Register, to evaluate if there is a way to reach out to all HOAs on the issue of dam armoring.

Mr. Huguley amended his motion to allow staff to approach SCEMD to inquire about adding other dam armoring projects.

The vote in favor was unanimous.
